This causes her to land on her knees where the patient slices her neck open. The patient stars running away down the empty road as sirens are heard in the background. (open ending)


Summary

To film this I will be using different types of shots such as, Wide shot, Close up shot and mid shot. I am using these to either capture the full picture or to grow tension between both characters and the audience

I am hoping that the final outcome looks like cinematography has been considered throughout this process. Also I want there to be similarities to my inspiration. Use of lighting will hopefully be used to its full potential. I can also achieve this by changing and filtering the film. I think a blue undertone will really bring out the darker side and shaded areas of the film.

Location Scouting/Risk Assessment



This is what my set will be. There will be a few changes when i start to film such as,

Personal photographs will be movie out of the way. This is due to the fact that the therapist does not show any personal items to patients because of the danger it may cause. In the film that I used as my inspiration The therapist also conducts her sessions in her own living room. I think this is to create a relationship and a comforting atmosphere to all the patients.

Other items such a pillows, and most of what is on the table on the left of the picture will be removed to make the scene more minimalistic. This creates an empty space and feeling. The outside area will not be seen at all as i have decided to use the

curtains as a way to hide it and to create a soft natural light.

I chose this area because it is more easy to manipulate the setting and the lighting goes well with my film. Also the actual lights are bright and fluorescent so if there is a need for harsher lighting I can use them.

COmparing this area to the counselling office inside the school there is a big difference.

This area is harshly lit with little to no natural lighting. Also there isn't much space to use here and i would



only have access to it one day a week which would be disastrous. It also looks like it was made for young people, which it was. However, my film does not have any accept of children in it. To film in here would be awkward because i wouldn't have much space to move the camera around.

All shooting of scenes will take place during 12th-19th of june

On the 12rd and 13th of June will I will start filming without the characters to produce test shots. This will help me plan what time of day I need to film to get the lighting I need and if the type of shots I want to use will work with the setting. The shots I want to use are panoramic mid shots, the panorama will move up starting at the bottom of the subject.

Filming, on this day, will start at 9 am. If the lighting isn't correct, I will film again at 10am. I am filming in the morning because the sun is bright and shines through the room I am filming in creating the lighting that i want.

The shots I will take when testing are the ones on my storyboard. These contain, Mid shot, long shot/ bird's eye pov, Panorama shot and close up shots. These are my examples





Shot	Description/Duration	Techniques
Patient in background blurred out. Foreground of therapists shoulders	The patient will be on the left side of the screen blurred out with half his face in darkness as the other side is light with natural light. The lighting will be easy to see but the detailed face will be more difficult. The shoulder of the therapist will take up 30% of the screen and be in focus.	By filming it this way it lures the audience in with mystery of who the people are. By filming the shoulder of the therapist it will lead the audience to believe that they are in the scene, making it even more intense. This means in the first shot I have already captivated the audience
The therapist hand in shot close up	This is of therapist writing down in her note pad. It shows some writing of personality disorders. Focus is out at first then comes in.	I will be using a focusing technique which will make the audience pay more attention and try to figure out what is going on.


